

BYLAW NO. 02-2016 A BYLAW TO REGULATE SPEED

A Bylaw of the Rural Municipality of Keys No 303 in the Province of Saskatchewan to REGULATE SPEED WITHIN THE MUNICIPALITY.

THE COUNCIL OF THE R.M. OF KEYS NO 303 IN THE PROVINCE OF SASKATCHEWAN ENACTS AS FOLLOWS:

1. This bylaw may be referred to as the Traffic Speed Bylaw.

2. **DEFINITIONS**

For the purpose of this bylaw, the following terms and words shall have the following meanings:

- (a) "administrator" means the Administrator of the municipality;
- (b) "council" means the Council of The Rural Municipality of Keys No. 303;
- (c) "highway" means a road, parkway, driveway, square, or place designated and intended for or used by the general public for the passage of vehicles, but does not include any area, whether privately or publicly owned, that is primarily intended to be used for the parking of vehicles and the necessary passageways on that area and does not include a provincial highway within the municipality as designated pursuant to the provisions of *The Highways and Transportation Act, 1997*;
- (d) "municipality" means The Rural Municipality of Keys No 303;
- (e) "designated officer" means the Royal Canadian Mounted Police, or any other person appointed to enforce municipal bylaws;
- (f) "speed zone" means any portion of a highway within The Rural Municipality of Keys No 303, as designated herein, and identified by a sign erected and maintained at each end thereof, indicating the maximum speed applicable thereto;
- (g) "vehicle" means a vehicle, trailer or semi-trailer or a motor vehicle as ascribed to by *The Traffic Safety Act*.

3. **INFRACTIONS**

(a) **Speed:**

- i. Subject to clause 3. (a) ii. or 3. (a) iii., no person shall operate a vehicle in the municipality at a speed greater than 80km/hr.
- ii. No person shall operate a vehicle at a speed greater than forty (40) km per hour in the speed zone areas as set out in Appendix A.
- iii. No person shall operate a vehicle at a speed greater than sixty (60) km per hour in the speed zone areas as set out in Appendix B.

4. **SIGNAGE**

Signs indicating the maximum speed allowed shall be erected at the point of entry or commencement of the zone area.

5. **PENALTIES**

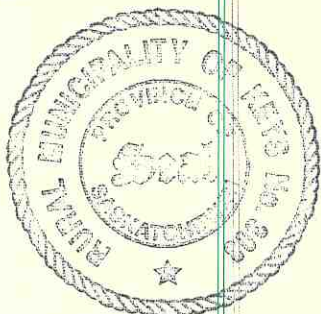
(a) **Speed:** The penalties for this traffic violation shall be liable to the penalties imposed by *The Summary Offences Procedure Act* and/or any other applicable legislation.

6. **REPEAL OLD SPEED BYLAWS**

Bylaw 3 – 85 is hereby repealed.

7. **COMING INTO FORCE**

This bylaw shall come into force and effect on the day it is approved by the Highway Traffic Board.

APPENDIX B

60 km SPEED ZONES

Yardsites:

- the most southerly 1000 feet of the road allowance East of the SE 28-33-09-W2 (Johnson)
- 1000 feet of the north-south road allowance along NW 22-33-03-W2 commencing at the South West corner of the quarter (Agar)
- 1000 feet of the north-south road allowance East of the NE 14-33-03-W2 commencing at the northern corner of the quarter heading south for 1000 ft (Bogucky)
- 1000 feet of the east-west road north of NW 10-33-03-W2 commencing at the northern corner of the quarter heading east for 1000 feet (Smith)
- 1000 feet of the east-west road allowance commencing at the South West corner of SE 23-31-03-W2 and heading eastward. (Kraynick)
- 1000 feet of the east-west road south of SE 18-32-02-W2 starting at the South East Corner and heading westward. (Mydonick)
- 1000 feet of the east west road north of NE 07-32-02-W2 starting at the North West Corner and heading eastward. (KKTLE)
- 2000 feet of the north south road starting at the North West corner of 18-31-02-W2 and heading both south and north 1000 feet each direction. (Kowalysheh)
- 1000 feet of the east west road starting at the NE corner of NE 29-31-02-W2 and heading westward. (Lazaroff)
- 1000 feet of the north-south road starting at the south corner of NE 10-32-02-W2 and heading northward. (Rakochy)
- 1000 feet of the north-south road starting at the north east corner of 04-32-02-W2 and heading southward. (Bobyk)
- 1000 feet of the east-west road starting at the north east corner of SE 14-33-03-W2 and heading eastward. (Johnson)
- 1000 feet of the north-south road starting in the south west corner of NW 01-31-01-W2 and heading northward. (Macek)
- 1000 feet of the east-west road starting at the south western corner of SE 33-31-01-W2 and heading eastward. (Bates)
- 1000 feet of the north-south road starting at north east corner of NE 31-33-01-W2 and heading southward. (HBC of Crystal Lake)
- 1000 feet of the east west road starting at the south east corner of SE 05-31-03-W2 and heading westward. (Stusek)
- 1000 feet of east west road starting at the south west corner of SE 02-32-03-W2 and heading both east and west 1000 feet in both directions. (Tarasoff)
- 1000 feet of the east west road starting at the south west corner of SE 23-31-03-W2 and heading west. (Kraynick)
